  - Discussed fixing up the classrooms to where students have social distancing.
  - The new police chief came to visit. Would like to come back and eat lunch with the kids and interact at recess time.
  - Hoping to have Veterans Day assembly for next year.
  - Cardigan Day is Thursday. All teahers and students are to wear cardigans and they have been making a kindness quilt.
  - Would like to add another set of steps to the parking lot. Some kids have been going up the muddy grassway.
  - Everyone is doing their best to stay apart and be social distancing.
    - 4.1.3 Mr. Scott Hendricks, JH/HS Principal, sent a paper discussing all things he was concerned about for the Junior High and High School.
      - Junior High Volleyball players will still have enough players to play this year.
      - Decisions will be made about High School Basketball playing after the IHSA's decision on November 19th.
